Quick Tip

Agendas - Be Structured, but Stay Flexible

When it comes to meeting planning, structure is an ally. It's important to have some standard parameters like length of meeting, order of business, and rules that guide your approach to discussion and debate. The Agenda should have the topics listed, with an estimated time noted, and whether the subject is for information, discussion, or approval.

Beyond these basics, keep room for a bit of flow in the meeting by leaving some extra time available – use this time when it is most helpful such as when a discussion is opening up new ideas, or when a presentation or explanation takes longer than planned but is still helpful.

Remember, as Emily Dickinson once suggested – to dwell in possibility.

An agenda is counterproductive when it becomes a confining experience. Remain open to new thoughts and directions, responding to the input provided by directors as the meeting progresses.
