1st Floor: "If you should do it, just do it."

Let's start 2019 with a look at what boards "must do" or "must review" on an annual basis. These can take the shape of an annual checklist or work plan and are based on your board's governance framework. These are requirements dictated by legislation, regulations, or other agreements and policies, and simply must be done.

Two items required by most boards is to establish an annual operating budget and hold an annual general meeting. There are many more and getting all of them done can lead to long checklists, automatic approvals, and over-use of valuable board time. If you're planning to start the year with a focus on checking those boxes, or creating the perfect documentation, maybe think again. The amount of effort and energy involved in all that paperwork might be reduced by just doing the right thing. Keep it simple - "if your board should be doing it - just do it".

Leverage the technology available in board portals such as Boardspace, and reduce paperwork to the essentials. Document what you must, but use most of your vital energy for developing and achieving your board's key outcomes this year.

2nd Floor: Shake up your Meeting Format



Shake any *boredom* out of your *boardroom* this year - 5 wellness principles to energize your meeting format for 2019

Does your regular meeting format include heavy meals, hours of meeting time with little exercise, or a lengthy checklist of approvals and reports with minimal participation or debate? Make wellness one of your first ‘board resolutions’ in 2019.

Boards come together and meet for one reason – to make decisions – and to make decisions that provide the best possible guidance to an organization and its stakeholders. Before people can make well-considered, thoughtful decisions, they need to have the right information, the right tools, a safe environment for frank discussions, and clarity of mind. The atmosphere in your boardroom should support and stimulate this critical thinking role. If the mood in your meeting space has become dull and sluggish, consider leveraging basic wellness principles to recharge and revitalize your upcoming board schedule this year.

Rooftop: Getting Unstuck & Sparking Creativity

Do directors sit in the same chair at every meeting of your board? Chances are good that people choose the same seat time after time. Once in the corner, always in the corner? Across from the same face every single meeting? Next to the same director making the same conversation each time? Are the seats formally assigned? Or is it just habit?
