Board Education News

The annual *Governance Professionals of Canada conference* was held this summer in beautiful Quebec City. Governance practitioners came together to hear the latest trends and inspiring ideas in governance. There was a wide variety of sectors and countries represented, but the conference theme of '**Agility, Resilience and Innovation**' was clearly present throughout the educational and keynote sessions.

The Conference began with a Keynote led by Second City Works. Alumni of the famed improv company Second City took to the stage to teach governance practitioners how to use improv-based skill sets to better prepare for boardroom demands. Readers can develop their own inner Saturday Night Live-inspired communication skills by taking one of their [corporate training workshops](#).

Both the *Canadian Credit Union Association (CCUA)* and the Ottawa-based *Strengths Performance Centre* built on this theme with sessions on personal strengths and applying them in a governance role. Bonnie partnered with Antoine Carriere from the Strengths Performance Centre to offer a workshop for delegates on the CliftonStrengths framework and applying them in a governance context. The [workshop](#) examined how to leverage personal strengths and apply them to develop one's influence and presence in governance. Taking a similar but slightly different angle, the CCUA recently completed a research project with York University to identify the profile of a [top-](#)

[performing director](#). This 'Director DNA' is being used to stimulate dialogue around the development of board members, board composition, and recruitment.

On the practical side, key tips were shared around *Presenting to Boards*. Delegates heard that 'less is more' – keep powerpoint slides to 4 bullets per slide, practice ahead of time, be sure to have a purpose for the presentation, beware of acronyms, and use humour! The speaker advised attendees to watch the Board Chair for cues – looking for body language that might indicate boredom or confusion and be ready to adapt your content mid-presentation if need be. Other interesting ideas included the speed of business and how it is pushing the date for delivery of board materials ever closer to the day of the actual board meeting. A board book finalized a week ahead, a standard well-known in the industry might no longer reflect the current situation needed for decision-making. Food for thought!

Over the course of the Conference, two interesting and provocative questions were raised:

1. Should nonprofit boards have only one mandate - fundraising?
2. Is the concept of a board passé given that meeting 4-6 times a year is unrealistic for keeping up with the speed of decision-making in business today?
